All About Us

Georgetown - Scott County Parks and Recreation (GSC Parks) is composed of 6 departments which offer diverse and comprehensive year-round programming for all ages at a number of facilities throughout Scott County.

> GSC Parks and Recreation Administration: Comprised of department managers and support staff who oversee programming and operations of facilities and parks.

Aquatics: Comprised of management and support staff for the operations and programming of three aquatic facilities.

Ed Davis Learning Center: Comprised of management and support staff for the operations and programming of Ed Davis Learning Center.

Facility Maintenance: Maintains 90,015 square feet of operated building space and two aquatic facilities.

Parks Maintenance: Responsible for maintaining 537 acres of natural areas/open space and 26 miles of recreational trails.

Pavilion: Comprised of management and support staff for the operations and programming of the Pavilion Community Recreation Center.

Marketing & Special Events: Responsible for marketing all parks and recreation parks, facilities, and programs. Organizes community wide special events. Conducts performance analysis for the department.

Conservation






Your GSC Parks by the Numbers



Launched in 2009, these agency performance resources assist park and recreation professionals in the effective management and planning of their operating resources and capital facilities.

Aquatics

The Aquatics department of Georgetown–Scott County Parks and Recreation strove to bring new opportunties throughout 2018. With the statisitical information from surveys and community feedback determining which programs worked and/or did not work in 2017, the department was able to focus more resources on successful programming. The department dropped Parent's Night Out and the Explore Outdoors series to focus more on reinvigorating our aquatic staff and how our Suffoletta Family Aquatic Center will operate in the summer of 2019. We also used this time to bolster programs such as Lifeguarding Training and Lifeguarding Instructor Training.





Swim Lessons

The American Red Cross Learn-to-Swim program has allowed us to offer crucial life-saving skills to our community. This year's swim lesson sessions provided instruction to 557 participants, which is a 9% increase from 2017 and a 28% increase from 2016.

Get to Know Your Local Superheros

This program introduces the community to first responders such as EMTs, Firefighters, and Police Officers. Participation was free with a paid admission to Suffoletta Family Aquatic Center. With this event, many members of our community learned that first responders are here to help all of us in a variety of ways, sharing safety guidelines, and who to call when you're in trouble.

Haunted Swamp

The 2018 annual Haunted Swamp was another success. Attendees to the event took a spooky boat ride through our haunted "swamp". Several ghouls donned SCUBA gear and swam around the deep end of the lap pool, jumping out to spook boat riders. This event not only provided a safe, unique, and fun venue for Halloween games and activities, it also taught lifejacket, boat, and canoe safety to attendees of the event.





Ed Davis Learning Center

Ed Davis Learning Center continues to be a beacon in the Boston neighborhood, the City of Georgetown, and Scott County. The department has continued to improve the relationship between community members and GSC Parks, as the community's perception of the department's commitment to caring about their well-being is at an all-time high. The average attendance per month, which includes programming or classes, special programming, special events, and walk-in attendance was 891 visitors; with a high in the month of June of 1,829, and a low in the month of December of 527.









Ed Davis Community Feeding

In 2016, a partnership was established between GSC Parks, Wesley United Methodist Church, St. Paul Lodge #11, and Queen Vashti #37 OES with the goal of providing meals to community members who may be homeless or underpriviliged. In 2018, we were able to offer this service four times, which provided 789 members of our community with healthy meals.

Kids Kitchen

In 2018, we had two sessions of Kid's Kitchen, with 20 (max) participants. Although the program fee increased it was well received by those who participated with 100% of the parents responding stating that the value of the program was worth the money spent.

| Ed Davis Farm Camp

Ed Davis Farm Camp is a free 3-day camp held in June. Twenty eight children were registered (max). Participants went on field trips to KSU Farm, Evans Orchard, Thoroughbred Training Center, Food Chain Lexington, and Smithtown Lexington. Farm Camp always has a diverse group of participants. This camp is provided through a partnership between GSC Parks, Ed Davis Community Inc., and Scott County Cooperative Extension Office.

Pavilion

The Pavilion had excellent programs and high facility usage. The 2017 - 2018 fiscal year recorded the highest number of attendance than in the past five (5) years with a 9% increase over the 2016 -2017 fiscal year. In 2018 we began collecting surveys for all our programs to evaluate the satisfaction of the programs, data on how to market more effectively, and to have an ongoing avenue to collect community feedback. The programs that were the most successful included Martial Arts, Girls Youth Volleyball Clinic, and Homeschool Gym & Swim. The Pavilion will continue to offer programming that will meet the needs of our community and continue to strive to make quality programming our top priority.





Martial Arts

With the help of our instructor, Brad Wells, we were able to teach boys/girls the introductory and advanced levels of martial arts. We had 144 participants. GSC Park's dojo at the Pavilion produced two Grand Champions and eight Gold and Bronze medalists at state level competition. Our martial arts team also earned a State Championship.

Home School Gym & Swim

The Home School Gym & Swim program has continued its success at the Pavilion. The program has had over 120 participants, who come and enjoy one-hour of organized active gym play and one-hour of swimming. This program has been very popular in our homeschool communities.

Little Jammers is now Start Smart

Little Jammers Basketball Clinic took a hit on post program evaluations. The constructive feedback from evaluations lead us to implement a nationally recognized program which focuses on parent/child participation. Start Smart Basketball will replace Little Jammers in the spring. This program will give children and parents a chance to not only learn, but have interaction while working on drills and fundamentals. Thank you parents for your feedback!





Facility Maintenance

GSC Parks Facility Maintenance takes care of 90,015 square feet of facility space as well as the adjacent outdoor space of each facility with 4 full-time staff. Facilities include the Pavilion, Ed Davis Learning Center, Suffoletta Family Aquatic Center, and the Concessions Building at Brooking Park. Working as a team, facility maintenance is also involved with community events and activities as necessary.







Snow Removal

GSC Parks takes care of snow removal at the Pavilion, Ed Davis Learning Center, and Brooking Park Concessions Building (if it is rented) when snow or ice hits. In order to be open at 5:30am for our patrons, we must have at least half of the Pavilion parking lot ready by 5:00am.

Skate Park

In 2018, we were able to make some significant maintenance improvements to the skate park at the Pavilion. We invested over \$15,000 in improvements to make the park safe for our users. Vandalism is often an issue at this park that we must address throughout the year.

Custodial and Maintenance Services

This department takes care of the maintenance and custodial services for the Pavilion, Ed Davis Learning Center, Suffoletta Family Aquatic Center, and the Concession Building at Brooking Park. The department maintains the grounds for the Pavilion, Suffoletta Family Aquatic Center, and Ed Davis Learning Center. The department recently completed bathrooms in the concession building at Ed Davis Park and repainted all the play features and lockers at Suffoletta Family Aquatic Center.

Parks Maintenance

Parks Maintenance is responsible for the care and maintenance of all open space within the GSC Parks system. In 2018, regular maintenance included; mowing of 528.7 acres on a regular basis, multiple storm clean ups, installing new speakers and painting the show ring at Brooking Park, adding rails and sidewalks to bathrooms at Brooking Park, installing new trees and shrubs at Scott County Park, installing a new scoreboard for football at Marshall Park, and much more.







Tunnel Project

Volunteers from Northside Christian Church provided GSC Parks with a beautiful mural project in the tunnel connecting Brooking Park and Scott County Park. This project has already reduced issues of graffiti which we have had there in the past.

Kendyl and Friends Playground

We are proud at the fundraising efforts of our community and the Kendyl and Friends Foundation to be able to provide a handicap inclusive playground which is now open and located behind the Pavilion.

Entrance to Scott County Park

At both entrances to Scott County Park, old plant materials were removed and a new landscaping was planted to enhance the entrances to the park with assistance of volunteers from a local business. We were able to recycle some plant materials to reduce costs and add new trees which were more appropriate for our available landscape beds.

Community Special Events

In 2018, GSC Parks expanded its offering and involvement in community special events. As a department we either hosted, partnered, supported, and/or participated in over 17 community special events. We are thrilled to have partnered and worked closely with Georgetown/Scott County Tourism Commission on multiple community wide events. GSC Parks and GSC Tourism have many shared goals to include highlighting Elkhorn Creek and our parks to encourage use by our community as well as visitors. Collectively, both GSC Parks and GSC Tourism work to provide safe, fun, and family friendly activities which draws participants from outside of Scott County.

Movies in the Park

GSC Parks was able to host our first movie in the park which featured Coco. Despite receiving our equipment late in the season and having a very short marketing window, we had over 100 people attend the event.

Elkhorn Float Fest

In partnership with Georgetown/Scott County Tourism Commission, we were to be able to provide the community with the Elkhorn Float Fest. Along with fulfilling several of our department's shared goals, this event also provided an opportunity for a KET TV segment to highlight Georgetown/ Scott County from a tourism perspective. This was the first large event in which GSC Parks and GSC Tourism were able to work together. We had 274 participants which exceeded our goal of 50. Based on our post event surveys, 65% said that they were very satisfied with the event and 72% said that they were likely to attend next year.

Party in the Park

Party in the Park (formerly Party on the Square) is a GSC Tourism concert series that has been hosted by tourism for many years. We are thrillled that in 2018, GSC Parks had the opportunity to assist with this event series. Sharing resources and manpower with our sister agency was an excellent growth opportunity for both organizations.








GSC Friends of the Parks

Georgetown Scott County Friends of the Parks had a great year in 2018. We were able to work with engaged community leaders and organizations that are helping us enhance park and recreation opportunities for all of Scott County. In 2019 we will be donating our first, of many, park benches made from recycled plastic! We are also working hard to establish a scholarship endowment and will be working with GSC Parks on numerous community events.



Purpose of GSC Friends of the Parks

Georgetown Scott County Friends of the Parks is a 501(c)(3) non-profit organization dedicated to enhancing, expanding, and improving GSC Parks & Recreation parks and programs.

Formation of Board

Although GSC Friends of the Parks has been in existence since 2012, in 2018 we were able to establish our first board of directors. The board consists of representatives from SC Schools, City of Georgetown, SC Fiscal Court, GSC Parks and Recreation, and six residents of Scott County.

Fundraising Efforts

GSC Friends of the Parks had several fundraisers in 2018. We hosted a cornhole tournament at Country Boy Brewing with nationally ranked players, provided concessions at the Elkhorn Float Fest and Movies in the Park, and participated in the Good Giving Campaign through the Bluegrass Community Foundation.
